In this challenging season, their support has been the brightest light, giving me hope. I'm deeply grateful for their support."



This past year, we responded to more than 73,000 211 requests through phone calls, texts, and emails.

DIRECT EMERGENCY ASSISTANCE

A crisis can hit at any moment—our emergency assistance fund is here to help. This program is a lifeline for those who have exhausted all other resources, supporting individuals facing eviction, families unable to pay utility bills, and more. With your support, we can help our neighbors get back on their feet.



Provided \$765,000 in direct emergency assistance.

Served 3,498 individuals.

COMMUNITY INVESTMENT

Investing in local nonprofits has been at the heart of United Way's mission for over 100 years. We're proud to have transformed this model to ensure we're reaching historically underfunded nonprofits.

Thanks to our generous donors, we invested \$4.7M in 68 local nonprofits this past year.

We were especially thrilled to welcome 17 first-time partners.

This grant process was powered by nearly 100 community volunteers who reviewed every grant application to decide where community dollars should be invested.

CELEBRATING COLLECTIVE IMPACT

Our inclusive funding model invests in nonprofits working across essential needs, early literacy, entrepreneurship, workforce development, and many other causes.

Thanks to our generous donors, 306,429 United Wayfunded services were provided through our nonprofit partners, a 50% increase from the year before.

Basic Need Services


Over 70% of the services we fund are considered basic needs, with food security being the greatest need. Last year, more than **33,000 United Way-funded meals** were provided.

We're not just showing up in times of crisis, we're also providing pathways to long-term stability, helping to break the cycle of financial hardship.

The power of our community investment model goes beyond the dollars – collaboration among nonprofits is the true driver of transformational change.

2023-2024 Funding in Action:

Out-of-School Programming

More than 4,200 school-aged children participated in a United Way-funded out-of-school program that has been proven to enhance academic performance and social skills.

Improved School Attendance

2,439 school-aged children improved school attendance thanks to United Way-funded services.

Parent School-Based Engagement

More than 2,100 parents became more engaged in school-based activities with their children thanks to United Way-funded services.

Upward Economic Mobility

1,877 adults completed a United Way-funded vocational training, earned a certificate, or secured a promotion or wage increase, enhancing their career pathways and economic opportunities.



TUTORING PROGRAM

We're proud to have reached 2,284 students through our tutoring program, launched in the spring of 2023.

The tutoring program leverages a high-dosage, low-ratio model for students in 1st through 8th grades. During the 2023–2024 school year, students from 31 schools participated in out-of-school programming at seven different partner sites.

We also worked with 40 schools in Hamilton County for in-school tutoring, with one or two tutors in nearly every public elementary school. For our volunteer tutors, it's more than just after-school and in-school support – it's about mentorship and building confidence to make a real difference.















NONPROFIT SUPPORT & INNOVATION

Building a more connected community around our nonprofits empowers them to serve more individuals and adjust to the changing needs of our community. We offer networking opportunities, capacity building training, and innovation idea jams to build deeper connections among our nonprofits.



Served 335 individuals in the nonprofit community through programming.

Connected 94 individuals through monthly nonprofit small group gatherings.

VOLUNTEERISM

Connecting neighbors who want to serve their community is a core part of our work. The following programs support volunteerism:

ihelp

An online volunteer portal where agencies can manage their volunteer projects and community members can sign up to help. Last year, 1,545 volunteer spots were filled through the ihelp program.

Engagement Groups

These mission-specific groups give local changemakers a community they can make a difference with. Our most engaged group is Emerging Leaders, young professionals between 21 – 40 taking collaborative action in volunteerism and leadership.

Onsite Volunteerism

Launched just this past year, our team has already partnered with local organizations to bring volunteering directly to our corporate partners. This inclusive model includes projects like building snack packs, stuffing backpacks, and more.

Day of Caring 2023

Day of Caring, sponsored by Elder's Ace Hardware, is our largest volunteering event of the year, bringing together corporate partners and community members to give back for one inspiring day of service. In 2023, we hosted over 500 volunteers who completed more than 40 projects across the community in just one day.

UNITED FOR WORKING FAMILIES

We're walking hand in hand with local employers to help shape the future of family-friendly workplaces. What started as a stand-alone event with over 400 community leaders has turned into a movement, focusing on flexibility for shift workers, parental leave policies, childcare support, and more.

ALICE@Work

This 3-day comprehensive cohort program, launched in 2024, equips people leaders with the tools and data they need to better support their ALICE (Asset Limited, Income Constrained, Employed) employees.

Insight Sessions

Last year, we hosted two Insight Sessions for our partners. The first, on childcare, brought together 20+ partners to address gaps in Hamilton County. The second was an ALICE simulation, where 30+ partners experienced the daily challenges faced by our ALICE community.



LOCAL FUNDRAISING

Our donors are the driving force behind our work, empowering us to serve more neighbors in need every year and build deeper connections in the community.
